Research projects

Dr. & Rector Ludovic-Mohamed Zahed is the only theologian in the world to establish such links between humanities, gender studies and religious sciences. During his adolescence in Algeria, L. Zahed has been trained to become an imam by studying Qur'an exegesis - *Tafsir al-Qur'an* - and the pillars of the Islamic orthopraxy - *usul al-fiqh*.

He is now master of cognitive psychology, graduate from the *Ecole Normale Supérieure* in cognitive sciences. Ludovic-Mohamed Zahed joined the Department of Anthropology at the EHESS (French school for advanced social studies) in fall 2010. Since then, he did publish his two PhD thesis: in anthropology of religion matters at the EHESS on the theme of Islam and homosexuality (defended and published); and his PhD in social psychology of religions at the University of Nantes (not defended but published).

L. Zahed general research perspectives are about radically alternative Islamic LGBT+ (Lesbian, gay, bisexual and transgender) corporalities and religiosities, as the vanguard of new Islamic liberation, inclusive and feminist, theologies. His terrain is focusing on LGBT+ Arab-Muslim and refugees organizations emergence, mainly in Europe, but also in North and South Africa, and the USA.

His fields of expertise include Muslim communities in Europe and Diaspora, and social grammars concerning norm negotiation around gender, sexuality, the public sphere, in relationship to alternative liberation theologies and mystical branches of Islam, such as Progressive, inclusive Islam and Sufism. He is the author of several books, translated in different languages, published by international institutions such as the Amsterdam University Press.

L. Zahed (co)organized or participated to several conferences, seminars and colloquiums in France, all over Europe, USA (as at the MIT), Morocco and South Africa. His research languages are Arabic, French and English. Today, L. Zahed is the international coordinator of the Euro-African network of citizens and intellectuals engaged and working towards an inclusive representation of Islam (INIMuslim); he is now the Rector of the CALEM Institute (Marseille, France)¹, developing holistic endeavours (neuro-psychosocial-theology paradigm)².

Research methodology

Empowering students, partners and customers in their process of acquiring expertise, in terms of appropriation and transmission, based on:

- Acquire intersectional academic knowledge (theoretical contributions, case studies, field dynamic participation in France, Europe, Middle-East, Africa, and elsewhere in the world)
- The development of ecological reflective capacities, in collaboration with all clients / participants to be empowered (reproducible skills)
- The awareness of contemporary issues at the heart of social dynamics, in connection with social cohesion, and a secular representation of the public sphere

Studies and research, field work, project endeavors, training of imams, trainers, & citizens, conferences, symposiums, communication, prevention, individual psycho-spiritual counseling.

- Accompanying interpersonal and institutional dynamics related to freedom of conscience, accommodations between the Republic and religious communities about inclusive interpretations of religious ethics, respecting the law and human dignity (as defined by the European Union);
- Support for social interventions, taking into account both the breadth, diversity and topographic complexity of the field that we are keen to understand, based on universally inclusive definitions of Secularism (*Laïcité*) and Republican social and ecological dynamics (bergsonian & todian perspectives);
- Support in the deconstruction of discriminating analysis grids, in order to understand the wealth of different epistemological referents without categorizing individuals in a performative manner, based neither solely on their origins nor on the social categories they belong to (whether ethnic, religious, professional, etc. - butlerian perspective);
- Accompanying the understanding, interpreting, and appropriating will to reinforce a practice of the spiritual traditions, within a universally egalitarian paradigm, consistent with an ethic based on the well-being of all, adapted to social contexts and present times (bourdivian perspective);
- Development of specialized indicators to put social and political data in perspective concerning what is freedom of conscience, and what reveals a radicalization process (psychological effects of infrahumanisation, stages of radicalism in a context of social agency quest, responsibility of the various social and political actors on these individual / community / Republican processes, etc. – leyensian & moscovician perspectives);
- Support in task planning which assesses the discriminatory / radicalization process (changes in socio-cognitive representations, group dynamic manipulation between honest people, hysteresis and "radical" rupture of positive feedback loops related to violence).
